Little Miss Bureau County Fair Queen & Court  
Code of Conduct Agreement

This undersigned hereby agrees to the following rules and stipulations put forth by the Bureau County Fair Board and Pageant Director. The agreement pertains to all contestants of the Little Miss Bureau County Fair Pageant.

1. Must be a resident of Bureau County, contestants for the Little Miss Bureau County fair must be 5 years of age by the actual date of the pageant ( Wednesday , August 22nd, 2007) and not have reached her 8<sup>th</sup> birthday by the pageant date. Proof of age may be requested.
2. If you are a title holder as Queen from another contest you are not allowed to compete in the Little Miss Bureau County Fair Queen Pageant. ( Excludes Runner-ups.)
3. Contestant agrees that the decision of the judges is final.
4. The newly selected Queen will represent Bureau County at the Bureau County Fair during Fair week August 22- 26, 2007 as an official hostess along side your Junior Miss Bureau Fair Queen 2007 and your Miss Bureau County Fair Queen 2007, as well as your respective courts.
5. The Queen will represent the Bureau County Fair in functions becoming of a Queen which may arise during the year. She will be chaperoned by the pageant director, or a parent or legal guardian at all functions where they represent the Bureau County Fair Association.
6. All personal appearances as Little Miss Bureau County Queen 2007 must be approved in advance by the pageant director, as well as any and all photographic sessions and pictures released for the Little Miss Bureau County Fair Queen 2007. The pageant director will set up all personal appearances of the Little Miss Bureau County Fair Queen 2007. The Queen will not set up her personal appearances.
7. The Queen must follow the direction of the Director, in regards to clothing and undergarments worn to Official events for age appropriateness.
8. It is the responsibility of the parent or legal guardian of the Little Miss Bureau Co. and Runner-up to provide all transportation to and from any events, and during the event they are participating in representing the Bureau County Fair Association.
9. Poor conduct unbecoming of a Queen will be tolerated. In the event a problem arises, the pageant director will sit down with both the Queen and her parents to address the situation. If a problem continues, it will be addressed by the pageant director and the Bureau County Fair Board and possible relinquishment of title may be suggested.
10. If newly selected Queen cannot fulfill all of the expressed duties and violates any rule, she will immediately relinquish her title, crown, and all prizes upon the direction of the pageant Director of the pageant director and the Bureau County Fair Board. The First runner-up will then be eligible for the title of Little Miss Bureau County Fair Queen 2007. All decisions made by the director and the Bureau County Fair Board will be final.
